Meeting of the Rock County Board of Canvassers opened at 9:00 a.m. on Monday, April 11, 2022. Members present: Larry Holterman (Republican Representative), Mark Fuller (Democratic Representative) and Lisa Tollefson (County Clerk). Others present: Kristine Kleisner (County Clerk Specialist), Ryan McDonough and Katie Janaska.

Agenda was approved moving the hand-count of Write-ins for County Supervisor District 11 contest to be done first. Approved unanimously.

The Board of Canvassers reviewed Inspectors' Statements and machine tapes for City of Beloit Wards 7-11.
