

**MINUTES OF THE BOARD OF CANVASSERS OF ROCK COUNTY
RECOUNT for Representative in Congress District 2 – Republican
51 S Main St., Courthouse Conference Center – 2nd Floor, Janesville Wisconsin
Saturday, August 20, 2022 through Sunday, August 21, 2022**

Saturday, August 20, 2022

Meeting was called to order at 9:07 a.m.

The Board of Canvassers met on Saturday, August 20, 2022, in the Conference Room (Room 250) on the 2nd floor of the Rock County Courthouse in Janesville, WI to conduct the recount of the August 9, 2022 Partisan Primary for Representative in Congress District 2 – Republican.

Members of the Rock County Board of Canvassers were introduced: County Clerk Lisa Tollefson Larry Holterman – Republican Representative and Mark Fuller – Democratic Representative.

Recount Workers/Observers: A daily list of recount workers and observers can be found at the end of this document.

County Clerk Tollefson welcomed everyone and thanked them for helping with the recount. Ground rules were reviewed.

The Board of Canvassers voted to hand count the ballots. A hand count was approved on the following vote: Lisa Tollefson, Larry Holterman and Mark Fuller voted in favor. Ayes- 3. Noes – 0.

County Clerk Tollefson reported that all municipalities involved in the recount had completed the reconciliation of their pollbooks/absentee applications, verifying absentee voters and election day voters, prior to the recount. There were no provisional ballots in Rock County in the August 9, 2022 Partisan Primary.

The recount followed the process below:

- The total number of absentee envelopes were counted and verified against the number of absentee voters.
- Used absentee ballot certificate envelopes were reviewed to determine sufficiency/insufficiency.
- Rejected absentee ballot certificates, if any, were reviewed to determine if they should have been counted.
- The ballot bags seals were confirmed against the inspectors' statements. Ballot bags opened.
- Total number of ballots confirmed for reporting unit.
- Number of absentee ballots confirmed.
- If a used certificate envelope was determined to be insufficient, then an absentee ballot was drawn down from all the ballots determined to be absentee ballots.
- Review remade ballots, if any.
- The ballots were divided into Republican ballots and others, then the Republican ballots were hand counted for each candidate, write-in and blank.
- Vote tallies were confirmed.
- Ballots were resealed in security ballot bags.

All municipalities were recounted on Saturday, August 20, 2022, except Town of Fulton, Town of Janesville, and City of Evansville, which were recounted on Sunday, August 21, 2022. Two reporting units, Town of Beloit Wards 1-3 and Town of Beloit Wards 9-12, were recounted on Sunday to confirm hand count.

Board of Canvassers recessed at 4:30 p.m. on Saturday, August 20, 2022.

Board of Canvassers reconvened on Sunday, August 21, 2022 at 11:00 a.m.

Board of Canvassers certified recount totals and signed certification.

Board of Canvassers adjourned on Sunday, August 21, 2022 at 2:30 p.m.

Charity Barry representative objected to 13 absentee ballot certificates missing the absentee witness's zip code. Board of Canvassers voted 3-0 to reject the objection – no ballots were drawn down. Current guidance does not require a zip code for a witness address.

Charity Barry representative objected to Special Voting Deputy (SVD) signatures on 20 absentee envelopes because party affiliation of the SVDs could not be determined.
