Call to Order: Chair Beaver called the Public Safety & Justice Committee meeting to order at 5:00 P.M. in the 911 Conference Room at the Rock County Communications Center.

Approve Agenda: Supervisor Bomkamp moved approval of the agenda as presented, second by Supervisor Zoril. ADOPTED.

Citizen Participation, Communications and Announcements: Supervisor Zoril addressed the committee regarding a call that he had received from a constituent. The constituent stated that he had a felony marijuana conviction and was facing up to 3 years in prison. The constituent informed Supervisor Zoril that he had trouble finding a public defender that wouldn't make him settle.

Approval of Minutes:

December 5, 2022 Minutes: Supervisor Bomkamp moved approval of the December 5, 2022 minutes, second by Supervisor Whitledge. Supervisor Zoril moved that the amount on page 4 be updated to read, "They are down 48 19 staff members currently." Supervisor Zoril moved that the amount be added to that same section, so the sentence reads, "This would ~~be very costly~~ cost about \$125,000 per month."
