Supervisor Bomkamp: Private ambulance services are not taking patients from nursing homes to hospitals for their appointments. EMS will be bringing a resolution to the County Board.

Kerstin: In April there will be a free employment and training resource event in partnership with Ford

Service Corporation and the Southwest Wisconsin Workforce Development Board.

David Salmon: The Janesville MPO have recently updated their TIP to reflect the funding amounts for mobility management this year.

Patty: Patty has been to the Capital twice this month to advocate for transportation. RSVP drivers received dementia friendly training.

John: People are having a difficult time getting transportation, mainly seeing a need for stretcher transportation.

Thomas: Beloit Transit is having a marketing push later this summer. They are looking at an app that will show where buses are in real time, alerts when buses are two minutes away, and more. A group of consultants will be doing a study on the Beloit Transit system for the possibility of using micro transit rather than a fixed route.
